

MAIL DEPOSIT PRACTICES



We have assessed the capabilities of our mail deposit locations to ensure they are properly equipped and capable of handling your mail efficiently and on time. Please refer to the chart below for more detailed information on the different location types, acceptable products/services, and maximum volume each location can handle.

Note: The product/service types and volume limits in the chart below do not apply to full-rate mail paid by postage meter or stamps deposited without a Statement of Mailing. Full-rate mail can be deposited at any Canada Post location.

The maximum number of containers or mail items identified in the chart below refers to total number of containers or mail items, regardless of service type, allowed per customer / mailer per day at the deposit location.

DEPOSIT LOCATION TYPES:

RVUs (Receipt Verification Units) accept **all products/services and all volumes** with the exception of Machineable Mail. Not all RVUs are approved to accept all types of Machineable Mail.

CDCs (Commercial Deposit Centres) are facilities that are equipped to accept, verify and process commercial mailings with the exception of Machineable Publications Mail (customers will be referred to the nearest RVU). Commercial mailings deposited at a CDC will continue to be **processed** at a Canada Post mail processing plant. CDCs are permitted to accept up to the equivalent of **2 shipping units (monotainers/pallets) CDC Level 1, 3 shipping units (monotainers/pallets) CDC Level 2 or 7 shipping units (monotainers/pallets) CDC Level 3** – of commercial mail per day per customer (customers exceeding these volumes will be referred to the nearest RVU).

Retail Post Offices can accept up to the equivalent of **5 containers (Retail Post Office Level 1) or 12 containers (Retail Post Office Level 2) or 18 containers (Retail Post Office Level 3)** of commercial mail per day per customer. Customers with volumes exceeding the permitted quantities or with Machineable Publications Mail or Machineable OS Incentive Lettermail or Postal Code Targeting will be referred to the nearest CDC or approved RVU.

DF (Delivery Facilities) that have not been designated as CDCs will not accept commercial mailings, except Neighbourhood Mail for local delivery (to a maximum of full coverage for that Delivery facility).
