



# Invoice Data Import Specifications

**Coming into effect July 2, 2025**

## Overview

On July 2, 2025, Canada Post will move from our legacy SAP platform to the next-generation, cloud-based SAP solution. As a result of this transformation, you'll benefit from streamlined billing and invoicing.

In addition to the invoice PDF, Canada Post offers the same information in an invoice file for reconciliation purposes. Customers who have multiple locations and a central payer can simply analyze the combined invoices for multiple accounts in this single data file.

### Use your data file to:

- Ingest information from the invoice file into a spreadsheet, database or financial reporting system.
- Review your Canada Post invoice data for all products
- Review invoice data for multiple accounts
- Conduct a more comprehensive analysis of your invoice by integrating it with your internal data

### Changes to the data file:

The specifications for the invoice data file outlined in this document will come into effect July 2, 2025. There are some changes being made to the file compared to what you see today. To help you identify any adjustments you may need to make on your end, each change is outlined in this document. Please note that some changes are being made to the invoice data file received through Connect or SFTP, while others are already included in the Connect file and are now being incorporated into SFTP file.

### Retrieving your data file invoice

If you have requested a data file, you will receive it at the same time as your regular invoices. The file invoice will continue to be sent through Connect or SFTP, Canada Post's secure electronic delivery method.

## Layout and File specifications

The Electronic Invoice Data File is a variable-length delimited text file that can easily be imported into database applications such as MS Access or spreadsheet applications such as MS Excel. Starting July 2, 2025, there are both format and data structure changes to the invoice data file, please note the following:

- the number of fields in the file is not changing
- the content within certain fields, fields lengths and field types will be changing, please refer to the invoice specification
- the file extension / type will be .txt
- the naming convention for the file will be Canada\_Post\_Invoice\_20241205124350\_1.txt
- the new file will be delimited with semi-colons (;) and will contain quotes (") as text qualifiers

The Electronic Invoice Data file consists of Header and Detail record layouts. The Header record provides information that can be used to identify the sender, the date and time the file was created and the email recipient. There are also data control values such as total documents (invoices), total dollar value of all transactions and total number of lines on the file that are used by Canada Post to validate that the file is complete and to ensure all transactions are accounted for. The Header record is a single line of data and is the very first line included in the file.

The Detail record contains transaction summary and line level detail information applicable to each invoice and adjustment transaction included in the file. Within the Detail record, transactions will be sorted by customer number and then invoice number sequence. All transactions on the file will consist of a single summary line and one or more lines containing details. The summary lines are designated with an "S" and will appear first in the file followed by the detail lines, which are designated with a "D". Files containing more than one invoice or adjustment for the same customer number will consist of multiple summary line items followed by detail line items as depicted in the example below.

Summary – Cust # 1 – Invoice 123  
 Detail – Cust # 1 – Invoice 123 – Line A  
 Detail – Cust # 1 – Invoice 123 – Line B  
 Detail – Cust # 1 – Invoice 123 – Line C

The record layout detailed below provides a list of the data elements and their specific location on the electronic data file. There are no changes to the Header portion of the data file, but note that data values are now separated by a comma (,):
